I no longer conduct direct family court assessments, focussing on consultancy, mentoring and training. We support local authorities, CAMHS services, OT practices, as well as individual practitioners. I also conduct doctoral supervision for other universities via research contacts (see below).

Clinical Work

Assessment of Parenting and Risk

I have over 25 years’ experience of working with Children and Families as a social worker, Children’s Guardian, Independent Consultant and as manager of a therapeutic and assessment team for a child-care organisation. I have experience and training in working with children and adults with disabilities and have particular interest and training in issues relating to Autism. I have written 100’s of reports and statements for the family courts in England and Northern Ireland and am experienced in giving evidence to the Court at all levels.

Assessment of Attachment in Children and Adults

In addition to my experience in Social Work, I have 20+ years of further psychological training, research, and study (to PhD level), in the field of parent-infant mental health. My training and accreditation includes administering and classifying the Adult Attachment Interview (DMM-AAI), the CARE-Index, the Parent Development Interview (Reflective Functioning Scale), and the School Age Assessment of Attachment (SAA). I have also developed and researched the Meaning of the Child Interview (MotC), and have been licenced to teach Child Assessment of Play and Attachment (CAPA: also known as narrative story stems, www.the-capa.com). I have longstanding experience of using all these in assessment and intervention with children and families and supporting others to do the same.

Research and Knowledge Exchange

The Meaning of the Child Interview and Network

I developed and conducted the validation study of the *Meaning of the Child Interview* (MotC: Grey 2014, Grey and Farnfield 2017a, 2017b, Grey ed., 2026), a procedure for classifying parenting interviews to understand parent-child relationships. The MotC offers a practical pathway for practitioners in applying attachment theory to understanding family relationships and planning intervention. It makes a unique contribution to the field of applied attachment theory in operationalising a systemic understanding of caregiving in a procedure developed to meet the needs of practitioners as well as researchers. It has been researched in its own right in normative and forensic settings (Grey and Farnfield 2017b), and has contributed to research on family relationships in families with a child with an autism diagnosis, child welfare and the family courts, professional relationships with clients, sibling relationships, the relationships of fathers with their children in adoption and in the COVID-19 pandemic (see www.meaningofthechild.org and publications list).

The MotC is being used in practice in social work, occupational therapy, CAMHS, and therapeutic services, in the UK and internationally. Co-authored case studies of its use and impact in the UK, Ireland and Iceland are presented in my forthcoming book (Grey ed. 2026, see publications). It is the subject of my forthcoming book; *‘The Meaning of the Child Interview: Making Sense of Parent-Child Relationships’*, due to be published as part of the Palgrave Texts in Counselling and Psychotherapy series. It is, in my understanding, unique in offering practitioners a practical, ‘how to’ guide to analysing adult relational discourse using attachment-based methods and using it for clinical formulation. This methodology, although well researched, has existed almost entirely within lengthy training courses and unpublished training manuals. It thus aims at bridging a significant gap between how attachment and caregiving theory is understood and how it is operationalised by researchers and practitioners (Duschinsky 2020).

The MotC's use in practice was demonstrated in evaluations of the **Norfolk Parent-Infant Mental Health Project (PIMAP)**. PIMAP used the MotC for case formulation with high-risk families, where children were at risk of going into care (Smith et al. 2018). The project showed considerable success in keeping children with their families and reducing the need for child protection involvement (McPherson et al. 2018 present an in-depth evaluation of the project's effectiveness; see Smith et al. 2018 for a more detailed description of the nature of the work carried out, including the role of the MotC).

The MotC has been incorporated into **SAFE (Systemic Autism-related Family Enabling)**, a multi-family systemic intervention for families who have a child with an autism diagnosis (McKenzie et al. 2019; Dallos et al. (2026). SAFE's £3 million+ bid for a national NHS trial has recently been awarded (subject to conditions); I have been asked to be an advisor on the board. This will include the use of the MotC to analyse parenting interviews both within and researching the intervention.

The MotC formed part of the **Knowing Me Knowing You** group intervention for adoptive parents whose child displays aggression and violence. This is evaluated and discussed in Barrow and Grey (2026) where it showed significant improvements in parental sensitivity and reflective functioning and reductions in parental stress.

The MotC is also part of **Sensory Attachment Intervention** (www.sensoryattachmentintervention.com). SAI has been developed by Éadaoin Bhreathnach, Occupational Therapist, Clinical Director of the Sensory Attachment Intervention Centre in Northern Ireland, which coordinates the teaching and accreditation of SAI internationally. The SAI model is designed for parents and children who are unable to regulate their arousal states and engage in therapeutic interventions. The approach has received international recognition Éadaoin Bhreathnach was awarded an Honorary Fellowship from Sensory Integration Education for her outstanding contributions to the advancement and promotion of Sensory Integration education, practice, and training. I am co-author to its first publication (Bhreathnach et al. 2026) within my book on the MotC and its applications (Grey ed. 2026).

The MotC is regularly used by **Milton Keynes Children's services** (including the Family Assessment and Support Team and the Family Drug and Alcohol Court Service – FDAC) within family assessment and support in a child protection and family court context (see Grey ed. 2026).

I am involved in providing ongoing support and consultancy to social workers, psychologists, therapists and other professionals in this procedure (see below). I co-ordinate an online network of those using and researching the MotC (see also www.meaningofthechild.org), running discussion and regular online and in person workshops to help practitioners apply the MotC in practice.

Training and Consultancy

I offer and have offered training and consultancy on the application of attachment theory to social work, therapeutic, and educational settings, including NHS trusts, local authorities, voluntary organisations, professional bodies, and private organisations, including BAAF, NAGALRO, Milton Keynes Social Services, TUSLA (Ireland), London Borough of Wandsworth and Action for Children, as well as directly through my own organisation, Cambridge Centre for Attachment (www.attachment.services). I teach on the Attachment Narrative Therapy programme.

I have presented at many conferences, nationally and internationally, including the International Association for the Study of Attachment (IASA) conferences in Bertinoro, Italy (2008), Cambridge (2010) and Frankfurt (2012), and the World Association of Infant Mental Health (WAIMH) Congresses in Edinburgh (2014) and Rome (2018). I gave a keynote speech at the Bowlby Centre Annual Conference 2025.

Current and recent consultancies include:

Treehouse Practice: Treehouse Practice is a specialised, team-based service for young people aged 0-25 years who have experienced trauma and adversity in their lives, and the adults who support them, based in Ireland. I consult regularly on their use of the Meaning of the Child Interview (MotC – see above).

Milton Keynes Children's Services: I have provided training and consultancy around the assessment of parent-child relationships, and our company, Cambridge Centre for Attachment (CCA) is contracted to provide clinical supervision and training to social workers and other employees.

Willows School Academy Trust: through our company Cambridge Centre for Attachment (CCA), we have provided training and consultancy in understanding the relational needs of children in their care and their impact on education and teaching.

Northern Health and Social Care Trust, Northern Ireland. I have provided training and consultancy on the MotC, as well as designed a training course for parental contact visits with their children, delivered by two colleagues to the trust.

Key Assets Consulting, Ireland. Key Assets offer an independent, one-stop-shop approach to delivering evidence-informed assessments and consulting service to professionals in Health Care, Social Care, Child Care and Legal services. I have trained their psychologists in the use of the MotC and assessments of child attachment.

Tengslamat Family Clinic, Iceland. Tengslamat primarily provides services to Child Protection Services, Social Services, and the Directorate of Immigration. It focusses on investigating attachment relationships and offering consultancy, therapeutic and supervision services. Tengslamat has hosted training for social and health care professionals all over Iceland on the Meaning of the Child Interview (MotC). This has been written up in Guðmundsdóttir R B, and Grey B (2026)

TIGALA, Ireland. TIGALA support children's guardians in the Irish Family Court service. We have trained the Meaning of the Child Interview and offer consultancy around the assessing and intervening in family attachment relationships.

Sofia University Bulgaria. We have been asked to teach the Meaning of the Child Interview and also offer training around the use of attachment assessment in research and clinical practice (March 2026).

SAFE Project: I collaborated in the feasibility study of SAFE (Systemic Autism-related Family Enabling, McKenzie et al. 2020), a project working systemically with families of a child with Autism, collaborating with Dr Becky Stancer (McKenzie) and the SAFE team, resulting in several publications (see below). SAFE's £3 million+ bid for a national NHS trial has been awarded and I have been invited to chair the board for this project.

Applied Social Science Group, University of Cambridge. I am currently supervising and/or supporting 2 doctoral projects on the University of Hertfordshire Doctorate in Clinical Psychology with the Applied Social Science Group, supported by Professor Robbie Duschinsky, Professor of Social Science and Health and Head of the Applied Social Science Group within the Primary Care Unit. These projects are part of the COACHES (CAMHS Referrals and Outcomes for Adolescents and Children with Social Workers) study, a four-year research collaboration including the NCB, the University of Cambridge, Kingston University, King's College London, the British Association of Social Workers (BASW) and the Care Leavers Association, examining data from over 70,000 young people across two NHS trusts.

Dr Pat Crittenden, Family Relations Institute, Miami, former pupil of Mary Ainsworth, now herself an international authority on attachment, developer of the Dynamic Maturational Model of Attachment (DMM). I helped develop a protocol for assessing attachment in adults and children in Family Court proceedings, through IASA (the

International Association for Study of Attachment). The protocol was tested over a 4-year period, involving reports submitted to 15 judges in 5 different countries internationally. I am co-author of the resulting paper (see below), as well as 2 further papers studying the use of the Adult Attachment Interview in forensic settings.

Dr Stephen Farnfield, former programme director in Attachment Studies, Roehampton University, and editor of the Routledge Handbook of Attachment. I helped develop and validate empirically the Child Assessment of Play and Attachment (CAPA: Farnfield 2016, www.the-capa.com), as well as participating in ongoing research.

Professor Rudi Dallos is professor emeritus in Clinical Psychology at the University of Plymouth and developer of Attachment Narrative Therapy. Together, we have developed a Family Attachment Interview (FAI) looking at a triadic understanding of attachment relationships and their utility for clinical practice. I am co-supervising and/or supporting 2 doctoral projects using the Meaning of the Child system of analysis to research the new interview.

Autism and Attachment Project. This is a collaboration between myself, Dr Mark Hudson (Associate Professor, Nottingham University), to coordinate Clinical Doctoral Research projects on the attachment relationships in families where there is autism, and clinical implications.
